- STAY OFF COVER-WILL NOT SUPPORT WEIGHT

IN THE SWIM SOLAR BLANKET DIV("Manufacturer") warrants, for a period of seven years from the date of purchase to the original consumer purchaser, that the IN THE SWIM SOLAR BLANKET shall be free from defects in workmanship or material, under normal use in accordance with the Manufacturer's Installation and Use Sheet instructions. For a period of 2 years from the date of purchase to the original consumer purchaser, and upon notification by the original consumer purchaser, Manufacturer will cause the IN THE SWIM SOLAR BLANKET to be inspected at no charge (excluding freight charge) to the original consumer purchaser, and if such inspection shall disclose the IN THE SWIM SOLAR BLANKET to be defective in workmanship or material, Manufacturer shall provide the original consumer purchaser, within a reasonable time, a replacement SOLAR BLANKET. If, during the remainder of this Limited Warranty, the original consumer purchaser shall notify the Manufacturer of a defect in workmanship or material of the IN THE SWIM SOLAR BLANKET, and which Manufacturer's inspection shall disclose to be defective in workmanship or material. Manufacturer shall replace the SOLAR BLANKET, and may charge the original consumer purchaser, for such replacement. From the date of purchase should the blanket exhibit a defect in material or manufacture IN THE SWIM shall pay, in the form of a store credit, the following percent of the manufacturer's suggested list price of the time of replacement per the following schedule:

Use:

- Install with bubble side down on water.
- If trimming is necessary, allow the blanket to rest on the pool until the packing folds have straightened. Trim with scissors.
- To maximize the performance of the cover, it should be left on the pool except when swimming or when the water reaches 90 degrees Fahrenheit.

What is covered under warranty?

- Delamination: This occurs when the 2 layers of the solar cover start to come apart or separate, causing the cover to fill with water.
- Seam separation: This occurs when the seams that hold the sections of the solar cover together start to come apart.

With respect to the foregoing warranty, ordinary wear and tear, and/or delamination due to improper storage or exposure of the SOLAR BLANKET (when out of the water) to the sun, shall not be considered a defect in workmanship or material.

Any implied warranties are limited in duration to the seven year period from the date of purchase to the original consumer purchaser.

Manufacturer will not be liable for any incidental or consequential damage resulting from any defects in workmanship or material.

This warranty gives the original consumer purchaser specific legal rights and the original consumer purchaser may also have other rights which vary from state to state.

Do:

- Install, maintain, and use in accordance to the Manufacturer's instructions.
- When SOLAR BLANKET is rolled or folded, whether on the water or not, it must be kept out of the sun by covering it with an opaque cover or by placing it in the shade.

DON'T:

- DO NOT put SOLAR BLANKET on water within 8-10 hours after super chlorinating (Shocking).
- DO NOT expose a rolled or folded SOLAR BLANKET to the sun when out of or on the water. Doing so will result in delamination.
- DO NOT subject the SOLAR BLANKET to extreme stress conditions which result in tears, cuts or damage.
- DO NOT store your SOLAR BLANKET at temperatures above 120 degrees Fahrenheit.

What is not covered under warranty?

- Bubble Damage: This occurs when the bubbles on the solar cover start to fall off. This is a chemical problem and often caused from the pool water not being properly balanced. Sanitizer levels should be in the recommended range.
- Fading or color bleaching out.
- Tears, rips, or cracks caused by the claimant.
- Damages caused by exposing the solar cover to the sun while removed from the pool (improper storage).
- Damage caused by misuse or animals.
